You automatically will receive one (1) Sweepstakes entry into the applicable Daily Entry Period drawing. On subsequent visits, follow the links and instructions to log in. You will receive one (1) Sweepstakes entry into the applicable Daily Entry Period drawing.

<u>Phase 3</u>: During Phase 3, visit <u>www.cartersholidays.com</u> and follow the links and instructions to complete and submit the registration form including a valid email address (first visit only). You automatically will receive one (1) entry into the Sweepstakes. On subsequent visits, follow the links and instructions to log in. You will receive one (1) entry into the Sweepstakes.

<u>Limit</u>: You may enter one (1) time per day during each Phase of the Promotion Period; you may earn one (1) additional Sweepstakes entry during Phase 1 for clicking on the button to learn more information about the Pajama Program. Multiple entrants are not permitted to share the same email address.
